#### Who did this, and why?

C4RJ volunteers who facilitate the cases referred by our partner police departments and DA's offices are trained to lead the parties through a process that's respectful, accountable, and transformative—changing how the parties see each other and themselves.

A young adult enters a restaurant with friends. He's drunk. He gets rowdy. The bartender refuses service.

Grabbing a fire extinguisher, the young man heads outside. When the owner confronts him, he pulls the pin on the extinguisher, sprays it in the owner's face, and drives away.

Charged with four felonies, he's given a choice by the Middlesex DA's office: proceed through the criminal justice system or take an option—restorative justice—that's available because the person most harmed, the restaurant owner, has agreed to it.


And why would a victim choose restorative justice? Like so many other victims, the restaurant owner wanted to confront the responsible party. He wanted to know: Why? What would make a person do this?



Answers emerged during the circle process. The responsible party was embarrassed, and sorry. He felt he had acted out of character. He was ready to accept responsibility for what he did and work to repair the harm. With the support of the C4RJ team, his family, and community, he did just that.

For his part, the restaurant owner was able to confront the responsible party, to hear, and to be heard. In the end, he said restorative justice was the right thing to do.


C4RJ worked on cases from 17 cities and towns in Middlesex County, and 2 in Suffolk County during FY19. 49.1% of these cases were felonies.


#### **MAP KEY**

The majority of assault cases worked on in FY19 were felonies as compared with one-third of assault cases worked on in FY18. The proportion of larceny cases that were felonies dropped as the threshold for felony larceny increased from \$250 to \$1,200 with the April 2018 criminal reform legislation.
