Strategic Plan Update

ast year C4RJ embarked on a strategic planning project. Our consultants from Team Training

Associates guided us through the process, which included four tailored internet surveys to our stakeholders (police partners, community members, C4RJ volunteers and funders), a fall board retreat to plan our future, and the formation of board-led committees that are dedicated to implementing our plans. On April 27th, the C4RJ board had a spring check-in with our consultants to see how the work is coming. There has been a lot of progress that we wanted to make sure you know about.

Responsible Growth Committee continues to monitor our expansion to make sure we are not over-extending ourselves geographically, financially or organizationally.

C4RJ added three new member communities in 2015—Burlington, Lincoln, and Maynard—and has seen a 33% increase in case referrals since 2014. We now accept juvenile referrals across Middlesex County through our partnership with the Middlesex DA's office. The 3-year pilot program in Malden High School has provided a model for establishing best practices for school-based RJ programs, and in January 2016 C4RJ become the fiscal sponsor for THRIVE Communities in Lowell.

Resource Committee began a corporate sponsorship initiative with a goal of raising \$40,000. Committee members are meeting with companies whose missions align with C4RJ's work and identifying lead sponsors for our fall event.

Internal Stability Committee supported the development of monthly announcement sheets for our volunteer teams so they know what is going on at the organizational level. C4RJ has prioritized professional development for staff, ongoing mini-trainings for current C4RJ volunteers and succession planning for transitions. We've also added a volunteer spotlight to our Facebook page, appearing on the 15th of every month.

Promote Our Value (Marketing) Committee created a brochure that describes our process and partners in late 2015. We have already given out almost 2,000 brochures. Committee members are in the process of creating customer profiles that will help target our marketing and outreach, and C4RJ is making an intentional effort to increase visibility on social media with more posts on Facebook and our new Twitter account.

The Learning Never Stops

4RJ volunteers recently completed a series of three workshops with local neuropsychologist Dr. David Gleason, titled Teaching Responsibility with Developmental Empathy. These workshops were designed to help us better understand how to work with clients who have anxiety, depression, ADHD and executive function challenges. Session one gave C4RJ volunteers a scientific and historical perspective on brain development and juvenile involvement with the legal system. Session two focused on executive functioning and how it relates to our reflective exercises. Session three took a deeper look at anxiety and depression and how they impact a young person's decision making.
